Faculty Member Participates in White House Summit on Antibiotic Stewardship



As part of the continued effort to combat antibiotic resistance, the Obama Administration convened a White House Forum on Antibiotic Stewardship on June 2 to bring together key human and animal health constituencies involved in antibiotic stewardship, which is the development, promotion, and implementation of activities to ensure the responsible use of antibiotics. As part of the event, more than 150 food companies, retailers, and human and animal health stakeholders, including [Nicole Brandt, PharmD, MBA](#), a professor of pharmacy practice and science, highlighted commitments to implement changes over the next five years to slow the emergence of resistant bacteria and prevent the spread of resistant infections. Dr. Brandt was invited to participate in the summit as president-elect of the American Society of Consultant Pharmacists (ASCP). She will become president of ASCP in November and participated in the summit in a panel discussion on antibiotic resistance in post-acute long term care settings. [Read more here.](#)

## Students Have "Stellar" Success at Residency Match

On March 20, thousands of fourth-year student pharmacists across the country waited with bated breath as the American Society of Health-System Pharmacists (ASHP) announced its Residency Match Day results. At the School of Pharmacy, 52 student pharmacists learned their fate as they matched to residency positions at institutions such as Johns Hopkins Hospital, Veterans Affairs San Diego Healthcare System, Oregon Health and Science University, Kaiser Permanente, and Yale-New Haven Health System. The School of Pharmacy achieved its highest success rate with this year's match, with 52 students matching to post graduate year (PGY) 1 positions across the country, which is an 84 percent match rate. Among the Big 10 pharmacy schools, we were third in total PGY1 matches and were eight in total PGY1 matches among all pharmacy schools in the country. The School of Pharmacy's joint [residency program](#) with the University of Maryland Medical Center also had a successful match. Eighteen first- and second-year residents and fellows will join or continue in the program this month to advance their knowledge and skills in a number of specialty areas, including ambulatory care, cardiology, geriatrics, pain and palliative care, and psychiatry. ## Faculty and Students Have Presence at the Maryland General Assembly

In an effort to bring

awareness to Maryland's elected officials about pharmacy education and the practice of pharmacy, faculty and students from the School of Pharmacy traveled to Annapolis throughout the 2015 legislative session to meet as groups and one-on-one with the state's policy makers. From participating in the Maryland Pharmacy Coalition's (MPC) annual Legislative Day to



testifying before House and Senate committees on specific bills, the School of Pharmacy had a strong presence at the General Assembly throughout the 90-day session. PPS faculty member's [Nicole Brandt, PharmD](#), professor, and [Bethany DiPaula, PharmD](#), associate professor, testified in favor of bills that authorize a pharmacist to administer self-administered drugs to a patient under specified circumstances and that expand the list of health care providers with whom pharmacists can enter into a collaborative practice to include nurse practitioners.
