

SOP Creates New Graduate Certificate in Medical Cannabis Studies



The University of Maryland School of Pharmacy has developed a new Graduate Certificate in Medical Cannabis Science, Therapeutics, and Policy, further cementing itself as the nation's leader in graduate studies in medical cannabis. The graduate certificate complements the existing Master of Science (MS) in Medical Cannabis Science and Therapeutics (MCST), which was the first program of its kind when it launched in 2019. A fully online program, the graduate certificate is a two-semester, 12-credit program that provides a foundation in cannabis pharmacology and clinical science, historical context, and current policy landscape. Mobile Health Team Demonstrates Positive Impact on Health Outcomes



The multidisciplinary Mobile Integrated Health-Community Paramedicine (MIH-CP) team, comprised of pharmacists, paramedics, and other comprehensive health workers, has found that its interventions improve medication adherence and ultimately health outcomes. The MIH-CP team, which includes pharmacists from the University of Maryland School of Pharmacy's e-Health Center, studied its impact on West Baltimore patients. Using data from a sixmonth period in 2020, it found that its intensive follow-up program improved prescription first-fill rates and medication adherence, but further interventions could be helpful too. A routine review in 2022 of the Pharmaceutical Health Services Research (PHSR) graduate program at the School of Pharmacy allowed internal selfstudy and external feedback to assess the program.
